Broan "Go Green-Get Green" Solar Swap Sweepstakes Official Sweepstakes Rules

ELIGIBILITY:

To enter the Broan "Go Green-Get Green" Solar Swap Sweepstakes (the "Sweepstakes"), you must: (a) be a citizen of the United States; (b) be 18 years of age or older at the time of entering the Sweepstakes and (c) not be considered a minor in your state of residence. Sweepstakes is void in New York and Florida where otherwise restricted or prohibited by law.
